

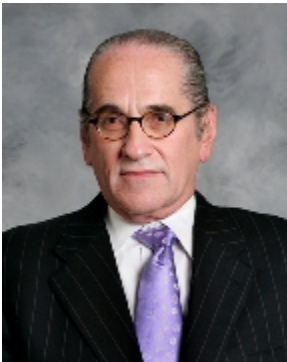
Isaacson Rosenbaum P.C. Attorneys Awarded Top Honors by Chambers USA 2009

- Over the years its attorneys have had successful outcomes with a number of notable clients in litigation cases including Qwest executives and government officials.

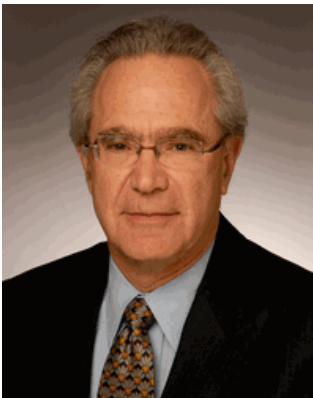
The following lawyers were ranked for their individual practices:
